Business Arising from Minutes

Statutory Public Hearings

Rezoning of PIDs 10093540 and 01297654 from the Rural Settlement (RS-1) Zone to the Residential Multi-Unit (R-2) Zone

Ms. Knudskov provided Council with a review of a proposed re-zoning in the Eastern Plan, which would provide for the development of multi-resident dwellings on a parcel adjacent to the East Antigonish Education Centre in Monastery. Ms. Knudskov provided an overview of the policies, comments from circulated agencies, and possible development plans for the proposed project. She noted that the public hearing was advertised in accordance with the requirements of the MGA, and she had received one phone call from a resident asking questions but not noting any concerns that they wanted brought forward at the public hearing. Councillor Mattie noted that he had talked to several residents in his district who are interested in units in this development and looks forward to its construction. There were no further questions or comments from Council. There were no parties in the gallery that spoke against or in favour of the proposed rezoning.

Warden McCarron provided updates on the Christmas on Main event, where he noted good attendance, an excellent concert, and highland dancing. The Santa Claus Parade was rescheduled due to weather and took place on November 27th with a good turnout. Santa's Tour took place on December 3rd and 4th throughout the County. Warden McCarron also attended a Care Van Committee meeting and noted that they have a new van in operation and their old van is now for sale. Finally, he noted that a Christmas Tree lighting at the Senior's Centre in St. Andrews was well attended by the community.
